Hereby Agree as Follows:

- 1. Grant of License. WARDEX hereby grants MLS Participant a license to electronically transfer information from WARDEX database or web site to the Participant's own database or web site ("download": RETS or Framed IDX Link) commencing as of date hereof terminating as hereinafter specified.
- 2. Website refreshing. MLS Rules Section 18.2.5 Not less frequently than every 12 hours.
- Warranty that Consultant is Party to the Agreement. Participant hereby warrants that the name(s) of all third party Computer Experts, Consultant, or Internet Service Providers (collectively, "Consultant") who are not employees of Participant are listed above as a party to this agreement.
- Consultant Not to Take Information from Participant's Possession. Participant agrees not to permit Consultant to take, and Consultant agrees not to take, any information whatsoever from WARDEX' database from Participant's possession or control either during the time Consultant is performing services for Participant, or thereafter.
- 5. Information to be retained by Participant Subject to WARDEX Rules. Participant agrees to retain in Participant's possession all information transferred pursuant to this Agreement, and further agrees that all WARDEX Rules and Bylaws will continue to apply to such information, even though it may be processed by Participant's own computer (as opposed to an online terminal).
- Downloading Procedure. The process and procedure for downloading shall be by such equipment and procedure as may be determined by WARDEX from time to time in its sole discretion.
- 7. Download Cost. All the cost of the download process will be the responsibility of the Participant. IDX links and first RETS feed are free. Additional RETS feed are \$50 each annually. No Fees or portion of the Fees will be refunded upon termination of this Agreement for any reason.
- Republication of Database. Participant may republish all of WARDEX database in strict compliance with WARDEX' then current Rules & Regulations on an Internet 8 site controlled by Participant and advertised as Participant's Internet site.
- Renewal. There are no auto-renewals. This agreement must be renewed annually by January 1. A renewal form only may be submitted if there are no changes. If the forms are not received by January 31, service may be temporarily interrupted. Any applicable fees must be paid prior to January 31.
- 10. Right to Terminate License. WARDEX shall have the right at any time and in WARDEX's sole discretion to terminate the right to transfer information (download) forthwith upon written notice to Participant. Delivery of such written notice to Participant shall constitute delivery of said written notice to Consultant. Both Participant and Consultant agree to cease downloading upon receipt of such notice.
- 11. Termination of Participant ship. Upon termination of membership or transfer to inactive status, Participant shall deliver all portions of information theretofore transferred from WARDEX's database (downloaded) by Participant to WARDEX, or, if WARDEX approves the delivery in writing, to another Participant of WARDEX.
- 12. Order of Signature of Agreement. This Agreement shall be signed by the Participant (broker), the Subscriber (Agent) and all Consultants as per below.
