Cape Cod & Islands Multiple Listing Service, Inc. Participant Data Access Agreement

This **AGREEMENT** is made and entered into by Cape Cod & Islands Multiple Listing Service, Inc. ("**CCIMLS**"), with offices at 22 Mid Tech Drive, West Yarmouth, MA 02673; the real estate brokerage firm identified as "Firm" on the signature page below ("**Firm**"); the Subscribers affiliated with Firm that are identified on the signature page and in Exhibit A, if any (collectively the "**Subscriber Party**"); and the individual or business association identified as "Consultant" on the signature page below, if any ("**Consultant**").

DEFINITIONS

1. For purposes of this Agreement, the following terms shall have the meanings set forth below.

AVM: An automated valuation model or similar service using mathematical modeling combined with CCIMLS Data and possibly other data, provided it can fairly be characterized as a valuation of real property, and only to the extent permitted by the CCIMLS Policies. An AVM need not include any human judgment or analysis. "AVM" includes broker price opinions (BPOs) and comparative (or comparable) market analyses (CMAs) to the extent they satisfy this definition.

CCIMLS Data: Data relating to real estate for sale, previously sold, or listed for sale, and to CCIMLS Participants (including text, photographs, and all other data formats now known or hereafter invented) entered into CCIMLS's databases by CCIMLS Participants and CCIMLS, or on their behalf.

CCIMLS Policies: CCIMLS's Rules and Regulations, as amended from time to time, and any operating policies promulgated by CCIMLS.

Confidential Information: "Confidential Information" information or material proprietary to a party or designated "confidential" by the party and not generally known to the public that the other parties may obtain knowledge of or access to as a result of this Agreement. Confidential Information includes, but is not limited to, the following types of information (whether in oral, visual, audio, written or other form): (a) all CCIMLS Data, except to the extent to which this Agreement and the CCIMLS Policies permit its disclosure; (b) IP addresses, access codes and passwords; (c) any information that CCIMLS obtains from any third party that CCIMLS treats as proprietary or designates as Confidential Information, whether or not owned or developed by CCIMLS; and (d) any information designated as confidential or private by any applicable state, federal, local or other law, regulation or directive. Confidential Information does not include information that is or becomes publicly available by other than unauthorized disclosure by the receiving party; independently developed by the receiving party; received from a third party who has obtained and disclosed it without breaching any confidentiality agreement; or already possessed by the receiving party at the time of its disclosure.

Data Interface: The transport protocols and data storage formats provided by CCIMLS for use by Firm, Subscriber Party, and Consultant; CCIMLS may modify the Data Interface in its sole discretion from time to time.

Firm AVM: Use and display of portions of the CCIMLS Data by Firm for AVM purposes subject to the provisions of Exhibit B of this Agreement.

Firm-Related Persons: Consultant, if any, and employees of Firm who are not Subscribers or broker/managers.

Firm Internal Use: Any use of those portions of the CCIMLS Data relating to Firm's own listings; and any use of those portions of the CCIMLS Data relating to listings of Participants other than Firm that exposes CCIMLS Data only to Firm-Related Persons and to Subscribers affiliated with Firm, subject to the CCIMLS Policies.

IDX: Use and display of portions of the CCIMLS Data under the IDX provisions of the CCIMLS Policies.

Mobile Applications: Any displays of IDX data authorized by CCIMLS Policies and listed in Exhibit A that are not web sites. "Mobile Applications" does not include mass media display of CCIMLS Data.

Participant: This term has the meaning given to it in the CCIMLS Policies. For purposes of this Agreement, "Participant" does not apply to participants of MLSs other than CCIMLS. Where applied in this Agreement to Participants other than Firm, "Participant" also includes Subscribers affiliated with those Participants for whom the Participants are responsible under the laws of the Commonwealth of Massachusetts.

Second Level Domain: "Second Level Domain" has the meaning given to it in this paragraph. "URL" means a web address, including the "http://" and any material appearing after a slash in the address. "Domain Name" means a URL, less the "http://" and any material appearing to the right of the next slash ('f') in the address. (So for example, in the URL "Http://janesmith.abcrealty.com/homepage.html", the Domain Name is "JANESMITH.ABCREALTY.COM".) "Top Level Domain" means the portion of the Domain Name to the right of the right-most period. (In the example, "COM".) "Second Level Domain" means that portion of a domain name to the left of the right-most period, up to the second period from the right, if any, plus the Top Level Domain. (In the example, "ABCREALTY.COM".) "Third Level Domain" means that portion of a domain name to the left of the second period from the right, if any, up to the third period from the right, if any, plus the Second Level Domain. (In the example, "JANESMITH.ABCREALTY.COM".).

Subscriber: Any person holding a real estate license in Massachusetts who is not a Participant but who is subject to a Participant's supervision under the laws of Massachusetts.

VOW: Use and display of portions of the CCIMLS Data under the Virtual Office Website (VOW) provisions of the CCIMLS Policies.

CCIMLS'S OBLIGATIONS

- 2. CCIMLS grants to Firm and Subscriber Party a non-exclusive, world-wide license to make copies of, display, perform, and make derivative works of the CCIMLS Data, during the term of this Agreement, only to the extent expressly permitted by and subject at all times to the terms and restrictions of this Agreement; any other use of the CCIMLS Data is hereby prohibited. All licenses hereunder shall terminate upon the termination of this Agreement. This Agreement is a non-exclusive license, and not a sale, assignment, or exclusive license. CCIMLS retains all rights not expressly granted herein.
- 3. CCIMLS agrees to provide to Firm, Subscriber Party, and Consultant, during the term of this Agreement, (a) access to the CCIMLS Data via the Data Interface under the same terms and conditions CCIMLS offers to other CCIMLS Participants; (b) seven days' advance notice of changes to the Data Interface; and (c) seven days' advance notice of changes to the CCIMLS Policies. CCIMLS does not undertake to provide technical support for the Data Interface or the CCIMLS Data. The Data Interface, together with access to the CCIMLS Data, may from time-to-time be unavailable, whether because of technical failures or interruptions, intentional downtime for service or changes to the Data Interface, or otherwise. Any interruption of access to the Data Interface or CCIMLS Data shall not constitute a default by CCIMLS under this Agreement.

FIRM'S OBLIGATIONS

- 4. Firm and Subscriber Party shall comply with the CCIMLS Policies at all times. In the event of any perceived conflict between the CCIMLS Policies and this Agreement, the CCIMLS Policies shall govern.
- 5. Firm shall use the CCIMLS Data obtained under this Agreement for Firm Internal Use, IDX, VOW, and Firm AVM use only. Subscriber Party shall use the CCIMLS Data obtained under this Agreement for VOW use

only. Any other use is strictly prohibited. Firm and Subscriber Party shall not make the CCIMLS Data or the Confidential Information available to any third party unless expressly authorized to do so under this Agreement. Firm and Subscriber Party may display the CCIMLS Data on web sites and Mobile Applications only to the extent permitted by the CCIMLS Policies and then only on a site or sites resident at the second-level and third-level domain(s) and Mobile Applications indicated on the signature page and in Exhibit A of this Agreement. The provisions of this paragraph shall survive the expiration or other termination of this Agreement in perpetuity.

- 6. Firm and Subscriber Party acknowledge that ownership and use rights relating to copyrights in the CCIMLS Data are defined in the CCIMLS Policies or in the terms of the participant and subscriber agreements between CCIMLS Firm and Subscriber Party, or both. Firm and Subscriber Party shall not challenge or take any action inconsistent with CCIMLS's ownership of or rights in the CCIMLS Data. The provisions of this paragraph shall survive the expiration or other termination of this Agreement in perpetuity.
- 7. If CCIMLS notifies Firm or Subscriber Party of a breach of the CCIMLS Policies or this Agreement and Firm or Subscriber Party does not immediately cure the breach, Firm and Subscriber Party shall hold Consultant harmless from any liability arising from Consultant's cooperation with CCIMLS under Paragraph 10.
- 8. Firm and Subscriber Party shall pay the fees, if any, that CCIMLS customarily charges other CCIMLS Participants for data access. Firm and Subscriber Party acknowledge receipt of CCIMLS's current schedule of such fees, if any. CCIMLS may in its sole discretion establish or modify its schedule of fees upon 30 days' written notice to Firm and Subscriber Party. Firm and Subscriber Party shall be liable for all costs, including reasonable attorney fees, associated with collecting amounts due under this Agreement.
- 9. Firm is surety for Subscriber Party's and Consultant's obligations under this Agreement. The provisions of this paragraph shall survive the expiration or other termination of this Agreement in perpetuity.

CONSULTANT'S OBLIGATIONS

- 10. Consultant shall immediately correct any breach of this Agreement or violation of the CCIMLS Policies within its control, whether committed by Firm, Subscriber Party, or Consultant, upon notice from CCIMLS.
- 11. Consultant acknowledges that (as among the parties to this Agreement) Firm and CCIMLS possess all right, title, and interest in all copyrights in the CCIMLS Data. Consultant shall not challenge or take any action inconsistent with CCIMLS's and Firm's ownership of or rights in the CCIMLS Data. The provisions of this paragraph shall survive the expiration or other termination of this Agreement in perpetuity.
- 12. Consultant shall not make the CCIMLS Data or the Confidential Information available to any third party, except on behalf of Firm and Subscriber Party and in a manner consistent with Firm's and Subscriber Party's obligations under Paragraphs 4 through 9 of this Agreement; nor shall it make any other use of the CCIMLS Data, whether commercial or personal. In the event that Consultant provides services to Participants other than Firm (or to Subscribers affiliated with Firm other than the Subscriber Party), Consultant must enter separate contracts with CCIMLS. Consultant must ascertain, using the Data Interface on a daily basis, that each Participant to which Consultant provides services remains an eligible Participant; and in the case of Subscribers, that each Subscriber Party remains affiliated with Firm. Failure to comply with the provisions of this paragraph, will result in CCIMLS terminating all of Consultant's access to the CCIMLS Data under this Agreement and all similar agreements. The provisions of this paragraph shall survive the expiration or other termination of this Agreement in perpetuity.
- 13. Consultant warrants that any effort or use of the CCIMLS Data will not constitute patent infringement of any third party. The provisions of

this paragraph shall survive the expiration or other termination of this Agreement in perpetuity.

- 14. Consultant shall pay the fees, if any, that CCIMLS customarily charges other consultants for data access. Consultant acknowledges receipt of CCIMLS's current schedule of such fees, if any. CCIMLS may in its sole discretion establish or modify its schedule of fees upon 30 days' written notice to Consultant. Consultant shall be liable for all costs, including reasonable attorney fees, associated with collecting amounts due under this Agreement.
- 15. Consultant is surety for Firm's and Subscriber Party's obligations to pay fees under Paragraph 8. The provisions of the preceding sentence shall survive the expiration or other termination of this Agreement in perpetuity. Consultant shall notify CCIMLS within five business days of any change to the information relating to it in this Agreement, including change of its corporate name or address.

AUDITS OF COMPLIANCE

16. CCIMLS may, or at its option may engage an independent third party to, review, inspect, and test the books, records, equipment, and facilities of Firm, Subscriber Party, and Consultant to the extent reasonably necessary to ascertain Firm's, Subscriber Party's, and Consultant's compliance with this Agreement ("Audit"). CCIMLS may conduct an Audit upon any notice reasonable under the circumstances. Audit activities may include, without limitation, obtaining full access to Firm's, Subscriber Party's, and Consultant's web sites, Mobile Applications, and systems to ensure that CCIMLS Data is displayed in accordance with the CCIMLS Policies; using all features available to end-users of Firm's, Subscriber Party's, and Consultant's systems that employ the CCIMLS Data; and posing as consumers to register and test services Firm, Subscriber Party, and Consultant make available to consumers using the CCIMLS Data. CCIMLS shall pay the costs it incurs, and the out-of-pocket costs Firm, Subscriber Party, and Consultant incur, as part of any Audit; provided, however, Firm or Subscriber Party shall be liable for all costs of any Audit that discloses that Firm, Subscriber Party, or Consultant has breached this Agreement. The provisions of this paragraph shall survive the expiration or other termination of this Agreement for one year.

CONFIDENTIAL INFORMATION

17. The parties shall protect the Confidential Information with the same degree of care they take to protect their own sensitive business information of like kind, but in no event less than reasonable care. A party may disclose Confidential Information if such disclosure is required by law or court order; provided, however, that such party makes commercially reasonable efforts to notify the others in writing in advance of disclosure. Within five days after termination of this Agreement, the receiving party shall return to the disclosing party all Confidential Information of the disclosing party. The receiving party shall also erase or destroy Confidential Information stored on magnetic media or other computer storage. An officer of the receiving party shall certify in writing that all materials have been returned or destroyed.

TERM AND TERMINATION

18. The term of this Agreement begins on the date that CCIMLS signs it. This Agreement shall terminate upon the occurrence of any of the following events: (a) immediately upon termination of Firm's privileges as a Participant in CCIMLS; (b) 30 days after any party's notice to the others of its intent to terminate; (c) 10 days after any party's notice to another that the other has breached this Agreement, provided the breach remains uncured; (d) immediately upon any party's notice to another that the other has breached this Agreement, provided the breach is not susceptible to cure, is one of a pattern of repeated breaches, or has caused the party giving notice irreparable harm; (e) immediately upon Firm's notice to a Consultant that Consultant is no longer designated to provide IDX, VOW, or AVM services to it; (f) with regard to any Subscriber Party, immediately upon any event

that results in the Subscriber Party no longer being affiliated with Firm; (q) as provided in Paragraphs 28 and 31.

19. In the event Firm's privileges as a Participant (or Subscriber Party's privileges of affiliation with Firm) are terminated while this Agreement is in effect, and CCIMLS subsequently reinstates those privileges, this Agreement shall automatically be reinstated if CCIMLS resumes its obligations under Paragraphs 2 and 3. In the event Firm, Subscriber Party, or Consultant breaches this Agreement and entitles CCIMLS to terminate under Paragraph 18, CCIMLS may in its sole discretion suspend its performance instead of terminating this Agreement. CCIMLS may make this election by notice to the other parties within three days after the initiation of the suspension. Firm's, Subscriber Party's, and Consultant's obligations hereunder continue during any period of suspension. In the event of any suspension or termination of this Agreement, Firm, Subscriber Party, and Consultant shall make no further use of the CCIMLS Data or any derivative works based on it (except the portions of it relating to Firm's own listings) until and unless Firm's or Subscriber Party's rights under this Agreement are restored.

GENERAL PROVISIONS

- 20. **Applicable law**. This Agreement shall be governed by and interpreted according to the laws of the Commonwealth of Massachusetts, without regard to its conflicts and choice of law provisions.
- 21. **Survival of Obligations**. The "Definitions," "Confidential Information," and "General" provisions of this Agreement shall survive its termination or expiration in perpetuity. Other provisions shall survive according to their terms.
- 22. CCIMLS's Remedies. (a) Injunctive relief: Because of the unique nature of the CCIMLS Data and Confidential Information, Firm, Subscriber Party, and Consultant acknowledge and agree that CCIMLS would suffer irreparable harm in the event that any of them breaches or threatens to breach its obligations under this Agreement, and that monetary damages would be inadequate to compensate CCIMLS for a breach. CCIMLS is therefore entitled, in addition to all other forms of relief, to injunctive relief to restrain any threatened, continuing or further breach by Firm, Subscriber Party, or Consultant, or any one of them, without showing or proving any actual damages sustained by CCIMLS, and without posting any bond. (b) Liquidated damages: Firm, Subscriber Party, and Consultant acknowledge that damages suffered by CCIMLS from access to the CCIMLS Data by an unauthorized third party as a result of disclosure of any passwords or an unauthorized disclosure of the CCIMLS Data to a third party would be speculative and difficult to quantify. Accordingly, as a material inducement to CCIMLS to enter into this Agreement, Firm, Subscriber Party, and Consultant agree that in the event Firm, Subscriber Party, Firm-Related Persons, or Consultant, or its employees, agents, or contractors, disclose any password to access the CCIMLS Data or disclose the CCIMLS Data itself to any unauthorized third party, regardless of whether such disclosure is intentional or negligent, Firm, Subscriber Party, and Consultant shall be liable to CCIMLS for liquidated damages in the amount of \$15,000 for each such disclosure and termination of this Agreement. Liability of Firm, Subscriber Party, and Consultant under this paragraph is joint and several.
- 23. Limitation of liability/exclusion of warranties. IN NO EVENT SHALL CCIMLS BE LIABLE TO FIRM, SUBSCRIBER PARTY, OR CONSULTANT FOR ANY INDIRECT, INCIDENTAL, CONSEQUENTIAL, SPECIAL, OR PUNITIVE DAMAGES (EVEN IF CCIMLS HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES), OR LOST PROFITS ARISING FROM THIS AGREEMENT OR ANY BREACH OF IT. IN NO EVENT SHALL CCIMLS BE LIABLE TO FIRM, SUBSCRIBER PARTY, OR CONSULTANT FOR ANY AMOUNT IN EXCESS OF THE GREATER OF (A) THE FEES FIRM. SUBSCRIBER PARTY, AND CONSULTANT HAVE PAID CCIMLS, IF ANY, IN THE YEAR IMMEDIATELY PRECEDING THE FIRST EVENT GIVING RISE TO ANY CLAIM FOR DAMAGES; OR (B) \$100. FIRM, SUBSCRIBER PARTY, AND CONSULTANT ACKNOWLEDGE THAT CCIMLS PROVIDES THE

- CCIMLS DATA ON AN "AS-IS," "AS-AVAILABLE" BASIS, WITHOUT REPRESENTATIONS OR WARRANTIES OF ANY KIND, EITHER EXPRESS OR IMPLIED, INCLUDING WARRANTY OF TITLE, NON-INFRINGEMENT, AND ACCURACY. CCIMLS SHALL NOT BE LIABLE TO FIRM, SUBSCRIBER PARTY, OR CONSULTANT FOR ANY CLAIM ARISING FROM INACCURACIES IN THE CCIMLS DATA, ANY FAILURE TO UPDATE THE CCIMLS DATA PROMPTLY, OR THE CCIMLS DATA'S INADEQUACY FOR ANY PARTICULAR USE, WHETHER PERSONAL OR COMMERCIAL. CCIMLS makes no warranty, including those regarding title, availability, or non-infringement, regarding trademarks licensed under this Agreement, if any.
- 24. **Dispute resolution; Attorney's fees.** In the event CCIMLS claims that Firm, Subscriber Party, or Consultant has violated the CCIMLS Policies, CCIMLS may, at its option, resolve such a claim according to the disciplinary procedures set out in the CCIMLS Policies, provided CCIMLS does not also base a claim that Firm, Subscriber Party, or Consultant has breached this Agreement on the same facts. The parties irrevocably agree, consent, and submit themselves to personal jurisdiction in the courts of the Commonwealth of Massachusetts located in Boston or the federal court of the United States situated therein, as applicable, which shall have sole and exclusive jurisdiction over any action under this Agreement not subject to CCIMLS's disciplinary procedures. If any party prevails in an action or proceeding to enforce or interpret this Agreement or any provision hereof, it shall be entitled to reasonable attorney's fees and costs for the legal action.
- 25. Indemnification. Subject to Paragraph 23, in the event a party breaches any provision of this Agreement, that party (the Indemnifying Party) shall indemnify the other parties, their subsidiaries and affiliated companies, and all their respective employees, directors, agents, and authorized successors and assigns (the Indemnified Parties), against any and all losses, damages, and costs (including reasonable attorneys' fees) arising from each claim of any third party resulting from the breach. Consultant indemnifies CCIMLS, Firm, Salesperson Party, or customers of CCIMLS, Firm, or Salesperson Party, to whom Consultant provides a product or service using CCIMLS Data, against any and all losses, damages, and costs (including reasonable attorneys' fees) arising from any third party claim of patent infringement. The Indemnified Parties shall (a) promptly notify the Indemnifying Party of any claim and give the Indemnifying Party the opportunity to defend or negotiate a settlement of any such claim at the Indemnifying Party's expense, and (b) cooperate fully with the Indemnifying Party, at the Indemnifying Party's expense, in defending or settling any claim. The Indemnified Parties shall be entitled to engage their own local counsel at the Indemnifying Party's expense.
- 26. **Notice.** All notices to be given under this Agreement shall be mailed, sent via facsimile transmission, or electronically mailed to the parties at their respective addresses set forth herein or such other address of which any party may advise the others in writing during the term of this Agreement; and shall be effective the earlier of the date of receipt or three days after mailing or other transmission.
- 27. **No Waiver**. No waiver or modification of this Agreement or any of its terms is valid or enforceable unless reduced to writing and signed by the party who is alleged to have waived its rights or to have agreed to a modification.
- 28. **No Assignment**. No party may assign or otherwise transfer any of its rights or obligations under this Agreement to any other party without the prior written consent of all other parties to this Agreement. Any purported assignment or delegation in contravention of this paragraph is null and void, and shall immediately cause this Agreement to terminate.
- 29. **Entire Agreement; Amendment**. Subject to CCIMLS Policies, this Agreement contains the full and complete understanding of the parties regarding the subject matter of this Agreement and supersedes all prior representations and understandings, whether oral or written, relating to the same. CCIMLS may amend this agreement by providing 30 days' advance notice of the amendment to all other parties; if any party continues to use the Data Interface or the CCIMLS Data after the expiration of the 30-day

notice period, that party will be deemed to have agreed to the terms as amended.

- 30. **Relationship of the Parties**. The parties hereunder are independent contractors. No party shall be deemed to be the agent, partner, joint venturer, franchisor or franchisee, or employee of CCIMLS or have any authority to make any agreements or representations on the behalf of CCIMLS. Each party shall be solely responsible for the payment of compensation, insurance, and taxes of its own employees.
- 31. **Severability.** Each provision of this Agreement is severable from the whole, and if one provision is declared invalid, the other provisions shall remain in full force and effect. In the event that any provision of this Agreement is held invalid or unenforceable by a court having jurisdiction over the parties, the invalid or unenforceable provision shall be replaced, if possible, with a valid provision which most closely approximates the intent and economic effect of the invalid provision. In the event any provision of the limitation of liability, exclusion of warranties, or indemnification is held invalid or unenforceable, this Agreement shall immediately terminate.

Under this Agreement, FIRM AND SUBSCRIBER PARTY ARE PERMITTED TO WORK ONLY WITH THE CONSULTANT NAMED HERE. If Firm or Subscriber Party chooses to engage a different consultant or additional consultants, Firm must enter into a new version of this Agreement with CCIMLS and each such consultant. Under this Agreement, CONSULTANT IS PERMITTED TO WORK ONLY WITH THE FIRM AND SUBSCRIBER PARTY NAMED HERE. Consultant may not use data obtained under this Agreement to provide any services to Participants other than Firm, or with Subscribers affiliated with Firm except the Subscriber Party. Consultant must enter into a new version of this Agreement with CCIMLS and each additional Participant or amend this Agreement with CCIMLS to add additional Subscribers affiliated with Firm as Subscriber Parties.

If Firm or Subscriber Party will perform its own technical work and there is no Consultant party to this Agreement, Firm should cross out the Consultant signature box. If this Agreement is for services to Firm only, and there is no Subscriber Party, Firm should cross out the Subscriber Party signature box.

Exhibit B – Firm AVM Data Use Requirements

This Exhibit governs any use of the CCIMLS Data licensed under this Agreement for use in AVMs.

- B.1. Firm may provide Firm AVM services to Firm's customers and clients with whom Firm has first established a broker-customer or broker-client relationship (as defined by state law); including completion of all actions required by state law in connection with providing real estate brokerage services to clients and customers ("Registrants"). Such actions shall include, but are not limited to, satisfying all applicable agency, non-agency, and other disclosure obligations, and execution of any required agreements necessary for performing AVM services. Registrants may include financial institutions, mortgage lenders, mortgage bankers, mortgage brokers, mortgage loan servicers, title or mortgage insurers, insurers of payments owned to owners of mortgage backed securities, Government Sponsored Entities (GSEs), or such other businesses or institutions having an interest in automated reports on property valuation or market conditions.
- B.2. Firm must obtain the name of and a valid e-mail address for each Registrant. Each Registrant must agree to the terms of use described in Section B.3 of this Exhibit. Firm must verify that the e-mail address provided by the Registrant is valid and that the Registrant has agreed to the terms of use.
- B.3. Firm shall require each Registrant to review and affirmatively express agreement (by mouse click or otherwise) to a terms-of-use agreement that provides at least the following:
 - B.3.1: that Registrant acknowledges entering into a lawful consumer-broker relationship with Firm.
 - B.3.2: that all information obtained by Registrant from Firm AVM is intended only for Registrant's internal use and may not be disseminated or reproduced without permission from CCIMLS.
 - B.3.3: that Registrant will not copy, redistribute, or retransmit any of the information provided, except in connection with Registrant's consideration of the purchase, sale, financing or other potential transaction related to the subject property of any AVM.
 - B.3.4: that Registrant acknowledges CCIMLS's ownership of and the validity of the CCIMLS's copyright in the CCIMLS Data.
- B.4. The terms-of-use agreement described in Section B.3 shall also expressly authorize CCIMLS and other Participants or their duly authorized representatives to access any Firm AVM for the purposes of verifying

- compliance with CCIMLS Policies and monitoring use of Participants' listings by the Firm AVM. The agreement may also include such other provisions as may be agreed to between Firm and Registrant.
- B.5. Firm's right to use CCIMLS Data in any firm AVM is subject to the applicable office of Firm being a Participant in CCIMLS. In other words, an office of Firm that is not a Participant of CCIMLS may not use CCIMLS Data in any AVM provided to any third party.
- B.6. Firm must protect the CCIMLS Data from misappropriation by employing reasonable efforts to monitor for and prevent scraping or other unauthorized accessing, reproduction, or use of the CCIMLS Data.
- B.7. Firm must make any Firm AVM readily accessible to CCIMLS and to all CCIMLS Participants for purposes of verifying compliance with this Agreement and CCIMLS Policies.
- B.8. CCIMLS shall exclude from the Data Interface all "User Confidential Data." "User Confidential Data" consists of those portions of CCIMLS Data that Participants are prohibited from providing to customers orally and by all other delivery mechanisms. In the event that CCIMLS includes User Confidential Data in the Data Interface, Firm and Consultant shall ensure that it is not disclosed to Registrants or any other third party.
- B.9. Firm shall maintain an audit trail of Registrants' activity on any Firm AVM and make that information available to CCIMLS if CCIMLS has reason to believe that any Firm AVM has caused or permitted a breach in the security of the data or a violation of applicable CCIMLS Policies.
- B.10. Firm shall cause to be placed on any Firm AVM a notice indicating that the CCIMLS Data displayed on the Firm AVM is deemed reliable, but is not guaranteed accurate by the CCIMLS or other Participants.
- B.11. In any display of CCIMLS Data to any Registrant, Firm shall display the copyright notice of CCIMLS. The copyright notice should take one of the following forms: "Copyright 2015 Cape Cod & Islands Multiple Listing Service, Inc." or "© 2015 Cape Cod & Islands Multiple Listing Service, Inc." Firm shall replace "2015" with the current year as of January 1 each year.
